

Follow the steps below to get started with your new camera.


## Step 1. Download Kasa

Get the Kasa Smart app from the Apple App Store or Google Play, or by scanning the QR code below.



## Step 2. Log In

Open the app, and log in with your TP-Link ID. If you don't have an account, create one first.



## Step 3. Start Setup

Tap the  $\oplus$  button in the Kasa app and select Kasa Spot.

## Step 4. Configure Camera


Follow app instructions to configure your camera and add it to your home network.



## Step 5. Place Camera

Place your camera on a flat surface, or install it on a wall or ceiling with the provided indicator label and mounting screws.

- For cement wall: Drill two  $\phi$ 6mm holes with the help of indicator label, insert the plastic expansion tubes into holes and srew the mounting screws into the expansion tubes.
- For soft surface: Directly screw the screws in.




## **Use Your Camera**

You can view your camera from anywhere at any time with your phone. Go to the Devices page, then tap a camera to view the live video.




## **Change Camera Settings**


