

Follow the steps below to get started with your new camera.


#### Step 1. Download Kasa

Open the app, and log in with your TP-Link ID. If you don't have an account, create one first.




#### Step 3. Start Setup




Place your camera on a flat surface, or follow app instructions to install it on a wall or ceiling with the provided mounting screws.




# **Use Your Camera**

### **Change Camera Settings**


You can change the settings of your camera to meet various needs. Go to the Devices page, tap a camera, then tap 😤 to view and change camera settings.
