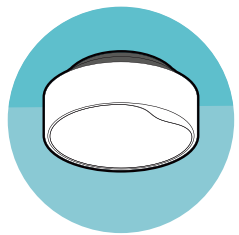


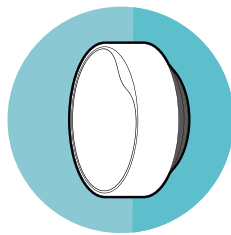

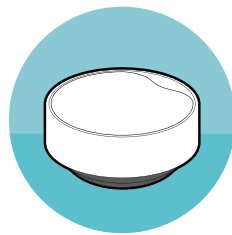

# About This Guide

# Appearance

Each mesh device has an LED that changes color according to its status, two 2.5 Gbps PoE ports, a power slot, and a reset button.

See the explanation below:

 Tip: The product label can be found at the bottom of the product.



**Pulse Yellow:**  
The device is starting up or resetting.

**Solid Yellow:**  
The connection quality of the device is normal.

**Pulse Blue:**  
The device is ready for setup or the device is establishing a mesh connection.

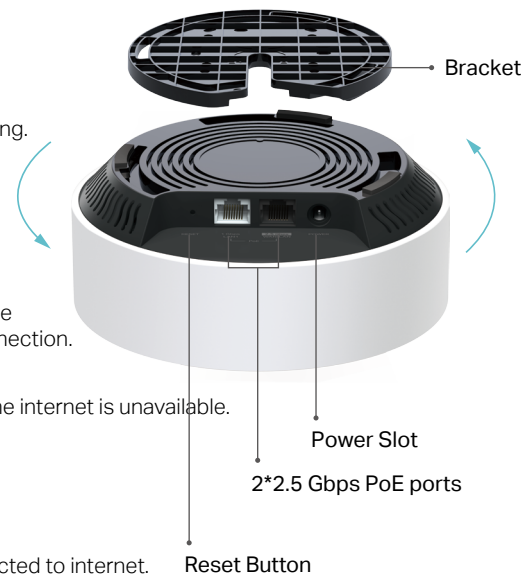
**Solid Blue:**  
The device has been set up, but the internet is unavailable.

**Pulse Green:**  
The device is upgrading firmware.

**Solid Green:**  
The device is all set up and connected to internet.

**Pulse Red:**  
The device has lost connection.

**Solid Red:**  
The device has an issue.



## Power Supply:

The mesh device can be powered via a power adapter or a PSE device (such as a PoE switch).

## Multi-Gig Internet Connection:

2× 2.5 Gbps ports make full use of gigabit speeds from your local ISP. PoE and WAN/LAN support meets all your internet demands.

## Reset:

Press for 1 second and release to reset mesh device to factory default settings. The light changing from pulsing yellow to solid yellow indicates a successful reset.

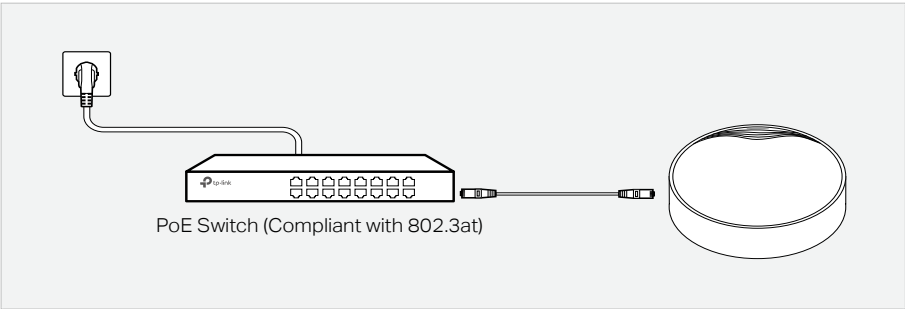

# Power Up Your Device

The mesh device can be powered via a power adapter or a PSE device (such as a PoE switch) which complies with Power Source Class 2 (PS2) or Limited Power Source (LPS) and Electrical Energy Source Class 1(ES1) of IEC 62368-1.

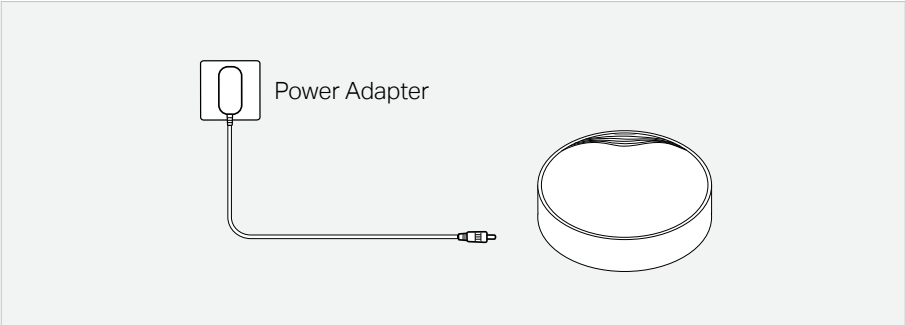
### Option1: Via PoE Switch (Compliant with 802.3at)

Connect an Ethernet cable from the PoE switch (compliant with 802.3at) to the mesh device's Ethernet port. The power should not be less than 18 W.



### Option2: Via Power Adapter

Plug one end of the provided power adapter into the power port of the mesh device and the other end to a standard electrical wall outlet.



# Set Up Your Mesh Network


First let's start by setting up the mesh network. Get the TP-Link Aginet app for iOS or Android, then follow the app to walk through the setup.

## 1. Get the Aginet app

Download and install the Aginet app from Google Play or App Store, or by scanning the QR code below.

## 2. Log in with TP-Link ID

Open the app and log in with your TP-Link ID. If you don't have a TP-Link ID, create one first.

 **Tip:** If you forgot your login password, tap [Forgot Password](#). The app will help you reset your password.

## 3. Select your device type

Search for and select your device type. If you have more than one mesh device, tap the question below the search box to check how to maximize the overall network.

## 4. Plug in your mesh device

Power off your modem, connect your mesh device to the modem, then power them both on.

If you don't have a modem, connect your mesh device directly to the Ethernet outlet.

## 5. Specify your mesh device's location

Select or custom a location for your mesh device. The location will be used as the name of your mesh device.

## 6. Connect your mesh device to the internet

Select the internet connection type and enter the information. If you are not sure, contact your internet service provider.

## 7. Create your mesh Wi-Fi

Create the network name and password for your mesh device and connect to it.

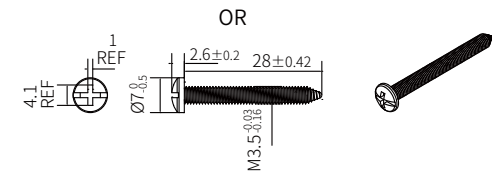
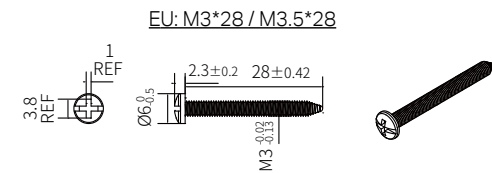
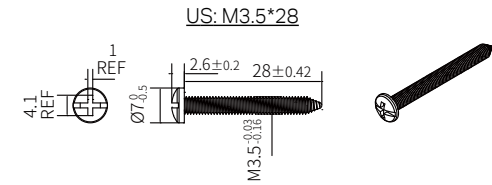
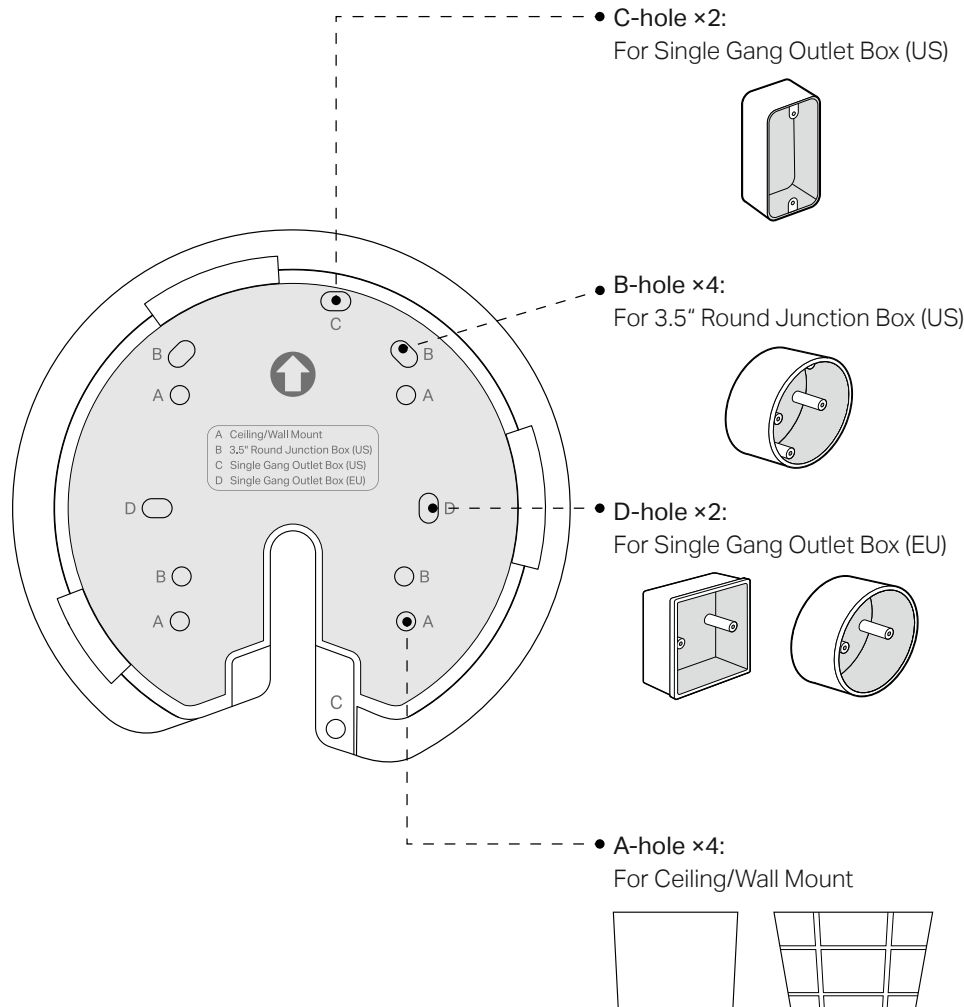
## 8. Setup complete

Your mesh network is now up. You can connect your devices to the mesh network.

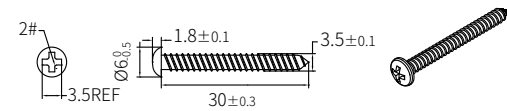

# Mount Your Device

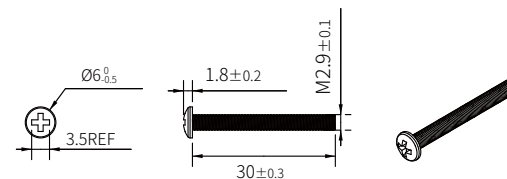
The mesh device can be mounted to the wall, the ceiling, or on a junction box, using the screws in the package. Choose the appropriate mounting methods.

## Option 1: On the Wall/Ceiling

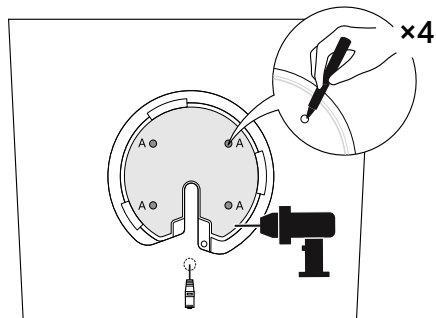
The mesh device can be mounted to the wall or the ceiling with the screws in the package.



Plastic Wall Anchors \*4

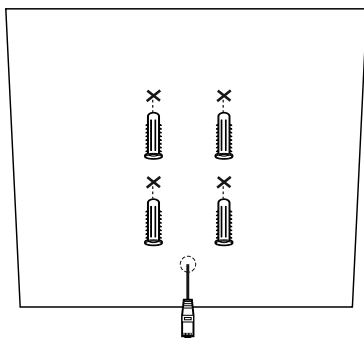


Self-tapping Screws \*4

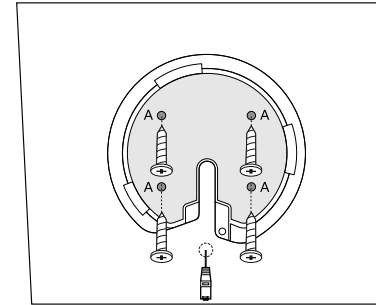


1. If your Ethernet cable feeds through the wall, position the mounting bracket above the cable hole.

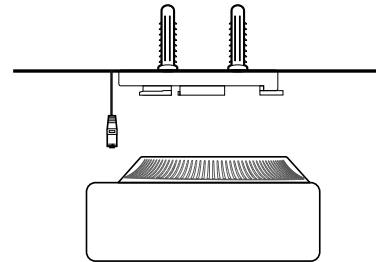
Mark four positions for the screw holes and drill four 6 mm (15/64 in) diameter holes at the marked positions.



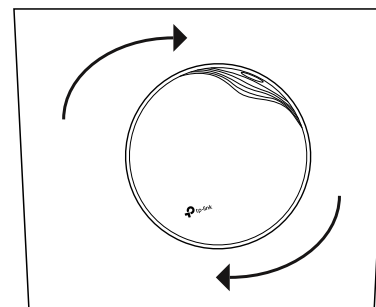
2. Insert the plastic wall anchors into the 6 mm diameter holes.



3. Secure the mounting bracket to the wall by driving the self-tapping screws into the anchors.
- Make sure the mounting bracket lies flat against the surface.



4. Connect the Ethernet cable to the Ethernet port on the mesh device.

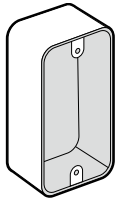


5. Orient the mesh device's LED according to the image, attach the mesh device to the mounting bracket, then rotate it clockwise until it locks into place.

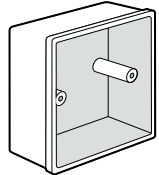


## Option 2: On a Wall Junction Box

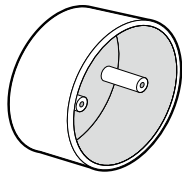
The mesh device can be mounted on a junction box. The junction box should be pre-installed with a running-in-wall Ethernet cable. Ensure that the mounting holes align to your junction box.



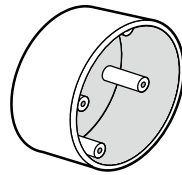

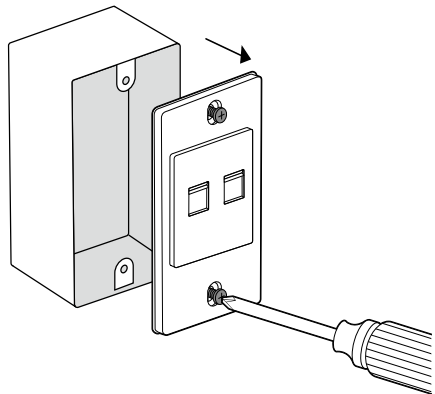

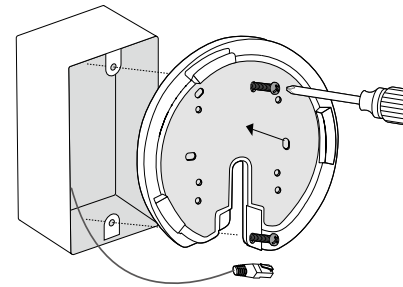

\*Here the standard US wall junction box is used as an example.



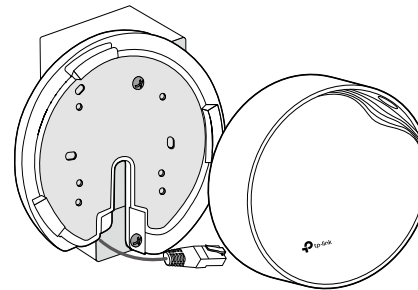
1. Detach the faceplate of the junction box with a Phillips screwdriver.



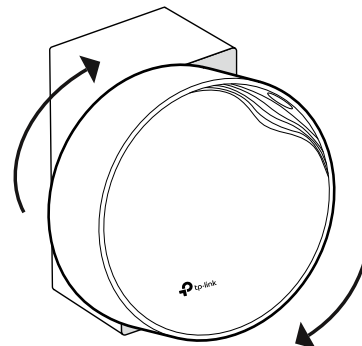
2. Feed the Ethernet cable through the mounting bracket. Insert the enclosed screws and tighten them with a Phillips screwdriver to secure the mounting bracket.

Notes:

1. Do not over tighten the screws.
2. If the enclosed screws do not fit the junction box, use the screws attached to the junction box instead.



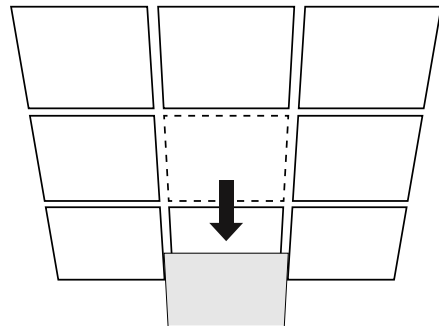
3. Connect the Ethernet cable to the Ethernet port on the mesh device.



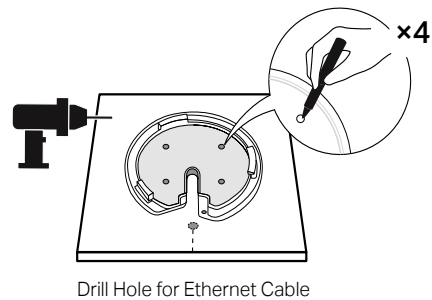
4. Orient the mesh device's LED according to the image, attach the mesh device to the mounting bracket, then rotate it clockwise until it locks into place.

## Option 3: In a Ceiling Tile

The mesh device can be installed in a ceiling tile with the screws in the package. Make sure the ceiling tile is larger than the mesh device.

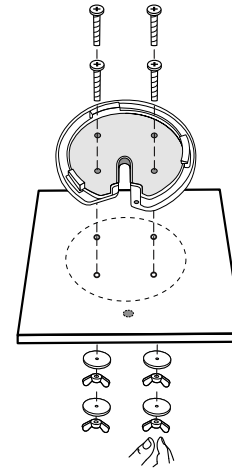


1. Remove the ceiling tile.

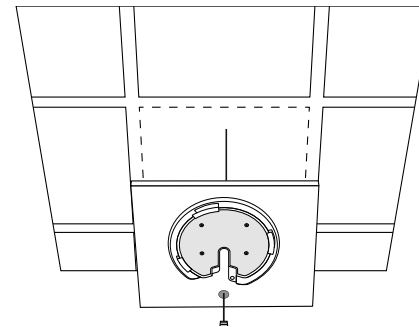


2. Place the mounting bracket in the center of the ceiling tile. Mark four positions for the screw holes and a location for the Ethernet cable hole.

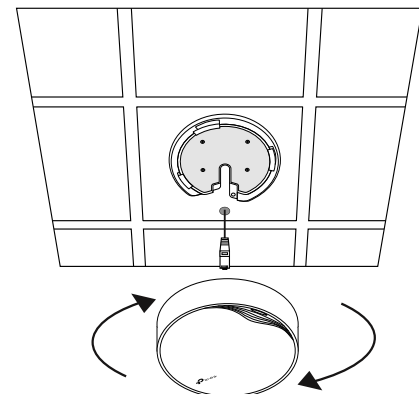
Drill four 4 mm (5/32 in) diameter holes for the screws and a 25 mm (63/64 in) diameter hole for the Ethernet cable at the marked positions.



3. Secure the mounting bracket to the ceiling tile using four pan-head screws, washers, and wing nuts.



4. Feed the Ethernet cable through the hole and set the ceiling tile back into place.



5. Orient the mesh device's LED according to the image, attach the mesh device to the mounting bracket, then rotate it clockwise until it locks into place.

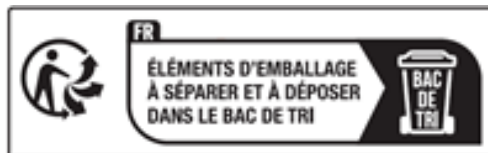
