1.1. Product Overview

Archer T5U Plus receives Wi-Fi signals on two separate bands for all your online needs. Choose the 2.4 GHz band for up to 400 Mbps of web browsing, email, and social media, or switch to 5 GHz for up to 867 Mbps of gaming, HD streaming, and large file downloads. †

- **MU-MIMO for Higher Efficiency** - MU-MIMO provides two simultaneous data streams, improving the throughput and efficiency of the entire network when working with a compatible MU-MIMO router. §
- **Super Speed USB 3.0** - Experience blazing-fast data transfers with USB 3.0 — the latest USB connectivity standard which is 10x faster than USB 2.0.*

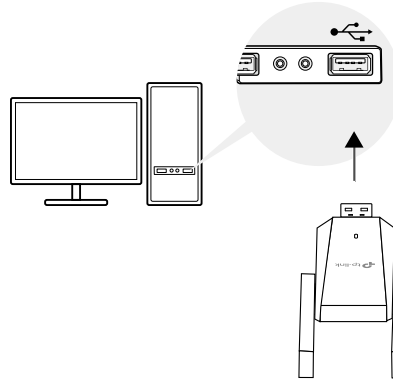

2.1. Install Driver

- This adapter supports Plug and Play feature. Insert the adapter into a USB port on your computer and then it is ready to use.




- If your operating system does not support this feature, follow the steps below:
 - a. Download the driver or check the new release at <https://www.tp-link.com/download-center>.
 - b. Unzip the downloaded folder and run the Setup.exe.
 - c. Select your adapter and follow the instructions to complete the installation.

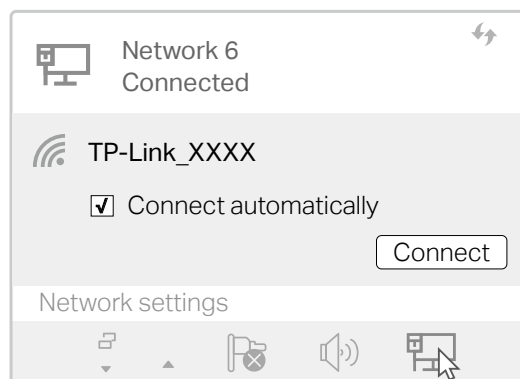
Notes:

- If you can't install the driver successfully, disable the antivirus software and firewall, then try again.
- In Windows 7, if a Windows Security message pops up, refer to [Troubleshooting > T4](#).
- If an unknown publisher message pops up, select Yes to continue.
- If Windows User Account Control requires admin credentials, type user name and password of your Windows administrator account.

2.2. Join a Wireless Network

You can join a wireless network via Windows built-in wireless utility. Follow the instructions below to use your computer system's built-in wireless utility:

1. Click the network icon on the taskbar (the icon might look like one of these: ).



2. Select the Wi-Fi network you want to join, and click [Connect](#). Enter the network password when prompted.

2.3. Uninstall Driver

The software uninstallation steps vary a bit from different systems. Here we take the instructions for Windows 10 as an example.

Go to [Control Panel](#) > [Programs](#), click [Uninstall a program](#), then double-click [TP-Link Archer T5U Plus Driver](#), then follow the on-screen instructions to complete the uninstallation.

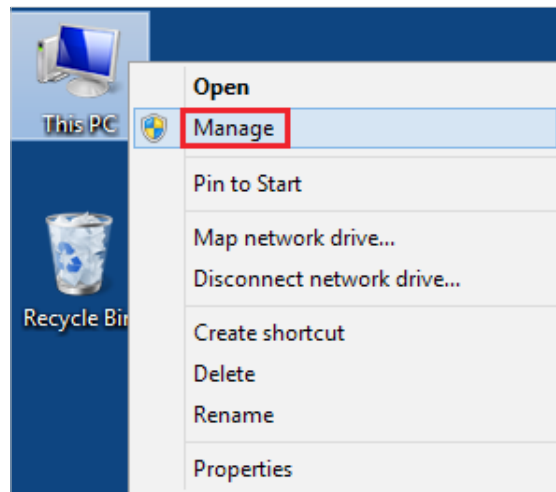
Appendix: Troubleshooting

T1. What should I do if the adapter is not detected?

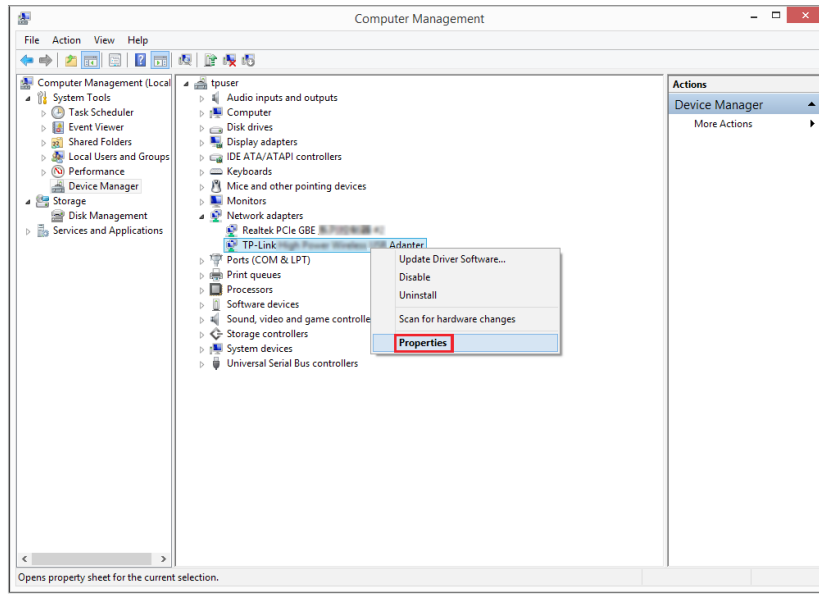
- Make sure the adapter is securely connected to the computer.
- Make sure you meet the minimum system requirements for the adapter and that the latest Windows and system updates are installed on your computer.
- Make sure you use the latest driver for your specific adapter. The latest drivers can be found at <https://www.tp-link.com/download-center>.
- Try a different USB port on the computer.
- Try restarting the computer or try using the adapter on a different computer.

T2. How to check if I have installed the driver for my adapter successfully or not?

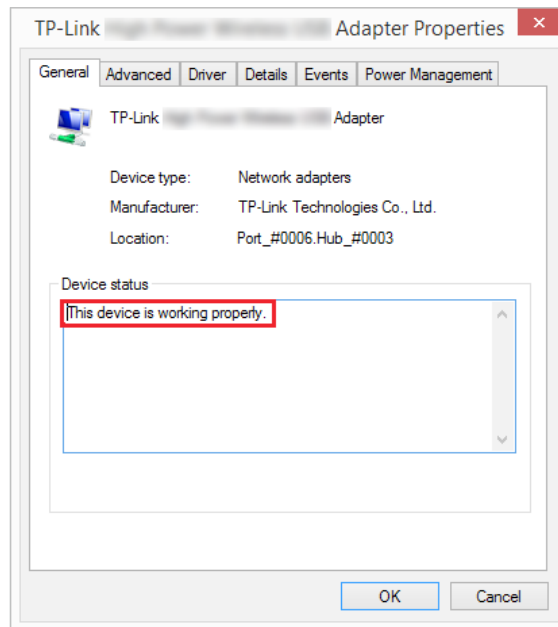
1. On your computer, please right click Computer icon and go to [Manage](#);



2. Open the [Device Manager](#) and go to [Network adapters](#), and then find the corresponding TP-Link adapter, right click it and then go to [Properties](#);



3. If you can see "This device is working properly." in the red box, you have already installed the driver successfully.



T3.What should I do if can't connect to the Wi-Fi after installing the driver?

- Refer to T2 to check if you have installed the driver for your adapter successfully .
- Make sure the adapter is securely connected to the computer.
- Disable the antivirus software and firewall, then try again.
- Try a different USB port on the computer.
- Restart your computer and try again.

- Re-install the driver and try again.

T4. How to find the hardware version of the adapter?

- The hardware version is printed on the product label on the package or the adapter. There is a character string "Ver:X.Y" (for example, Ver:2.0) in the Serial Number field, and the number X is the hardware version of the adapter.









