Introduction

Tapo Smart Hub works as your smart home ecosystem center. It connects up to 64 smart buttons, sensors, or Sub-1G switches** + 4 cameras or video doorbells (Tapo C420, Tapo C400, Tapo D230) to build a smart ecosystem for your home.

- **Works with Tapo Smart Devices*** – Connect up to 64 smart buttons, sensors, or Sub-1G switches** + 4 cameras or video doorbells (Tapo C420, Tapo C400, Tapo D230) to build a smart ecosystem for your home.
- **Smart Alarm & Chime** – Turn your hub into a smart alarm or chime by pairing it with Tapo cameras, video doorbells, sensors, and more. 19 built-in ringtones are also provided for your choice.
- **microSD Card Slot (Up to 512 GB)[†]** – Insert a microSD card to store recorded videos of the connected cameras and doorbells.
- **Wireless/Wired Networking** – Connect your Hub to your home network via wired or wireless connection.

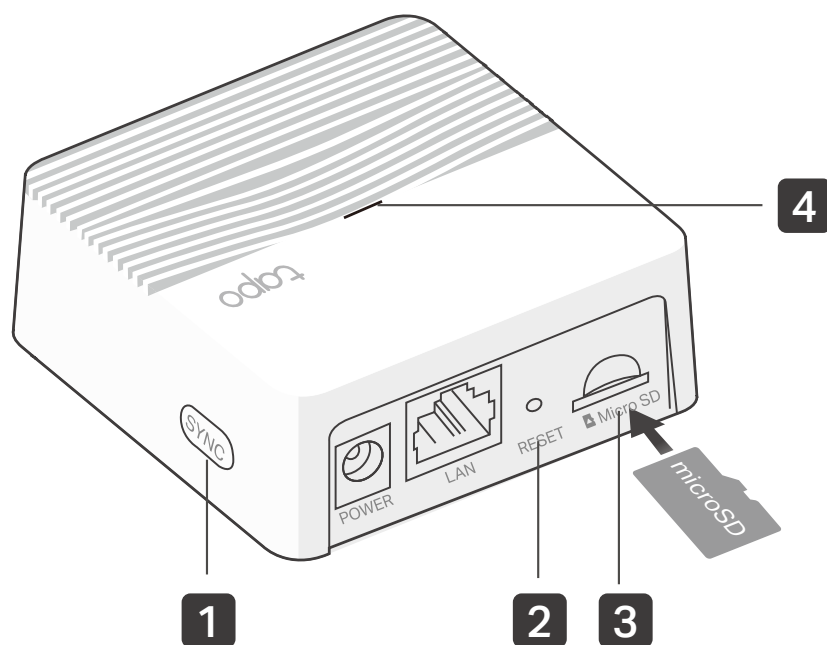

1 SYNC

Press to pair with the camera, or silence the hub when it rings.

2 RESET

Press and hold for about 5 seconds until the hub LED quickly blinks red to reset the hub.

3 microSD Card Slot

Insert a microSD card to record camera videos locally. Initialize the microSD card within the Tapo app first.

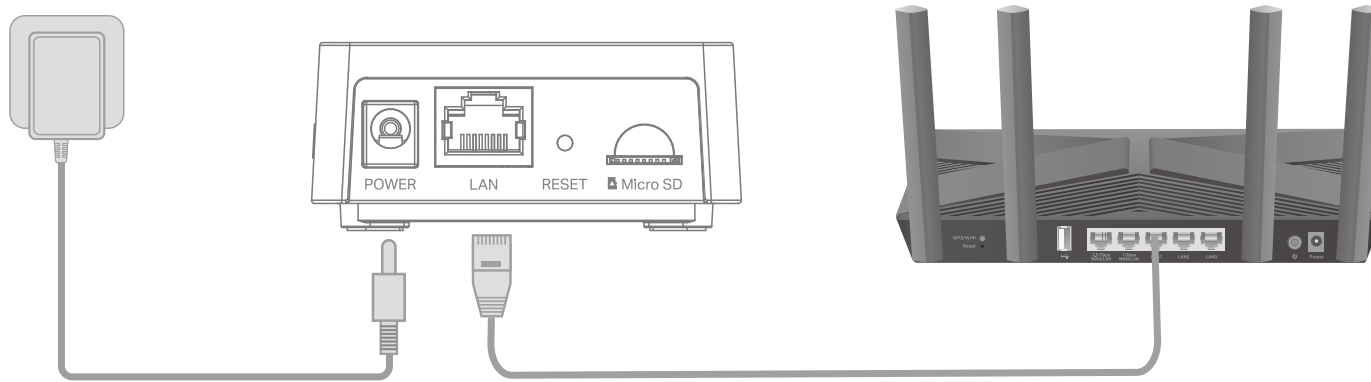

Set Up Your Hub

Follow the steps below to get started with your new hub.

Step 1. Connect the Hardware

Connect the hub to your home router using the Ethernet cable provided, and then power on the hub.

Get the [Tapo](#) app from the App Store or Google Play, or by scanning the QR code below.

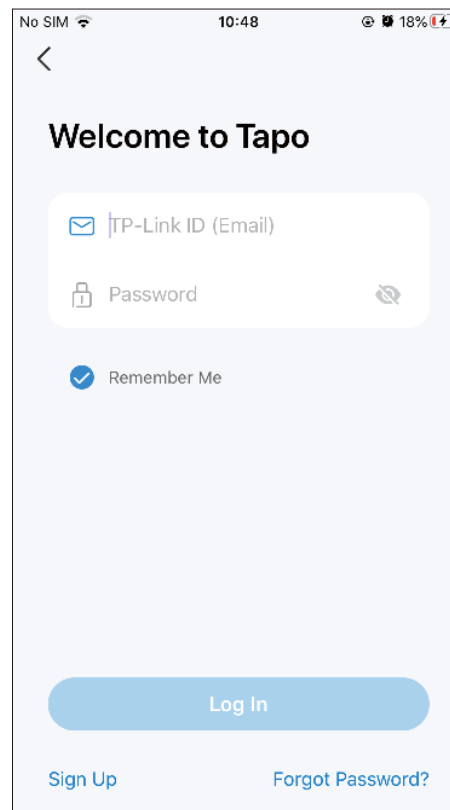

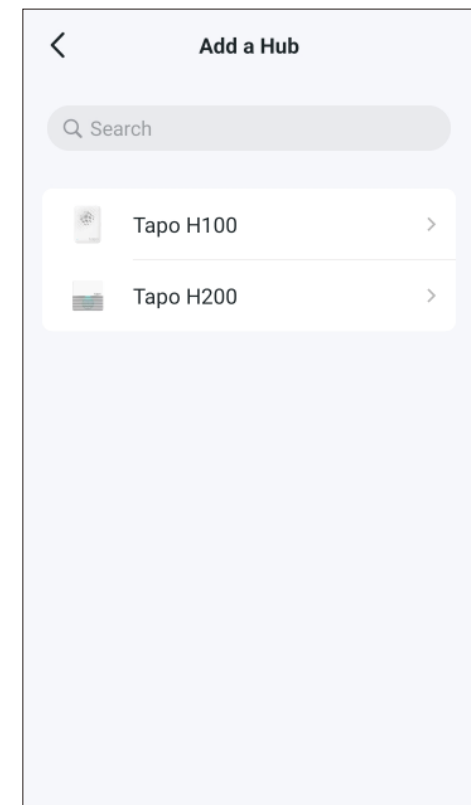
Step 3. Log In

Tap the $\oplus$ button in the app and select your model. Then follow app instructions to set up your hub.

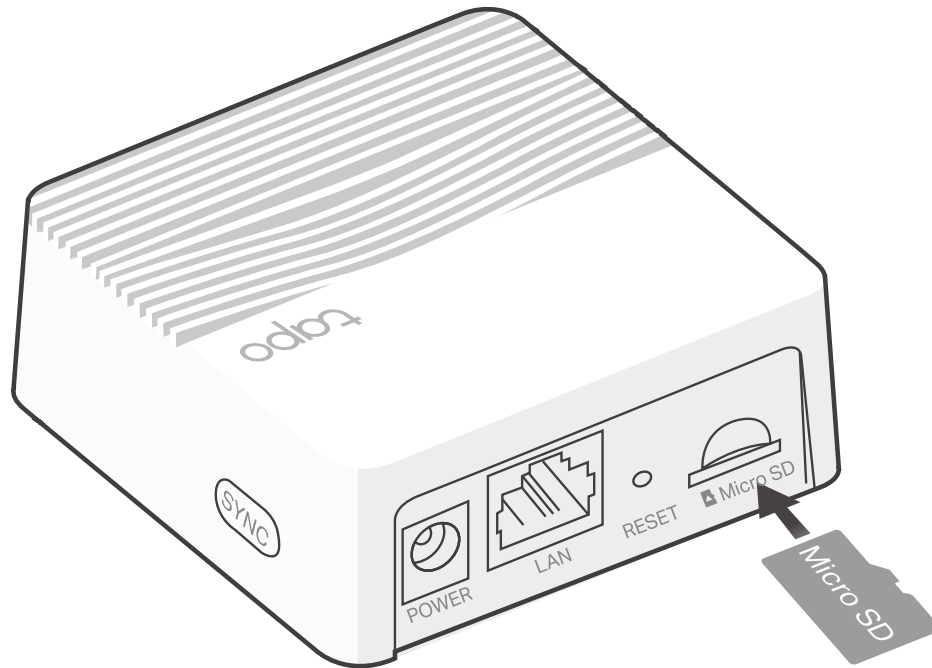


Install a microSD

Initialize the microSD card within the Tapo app.

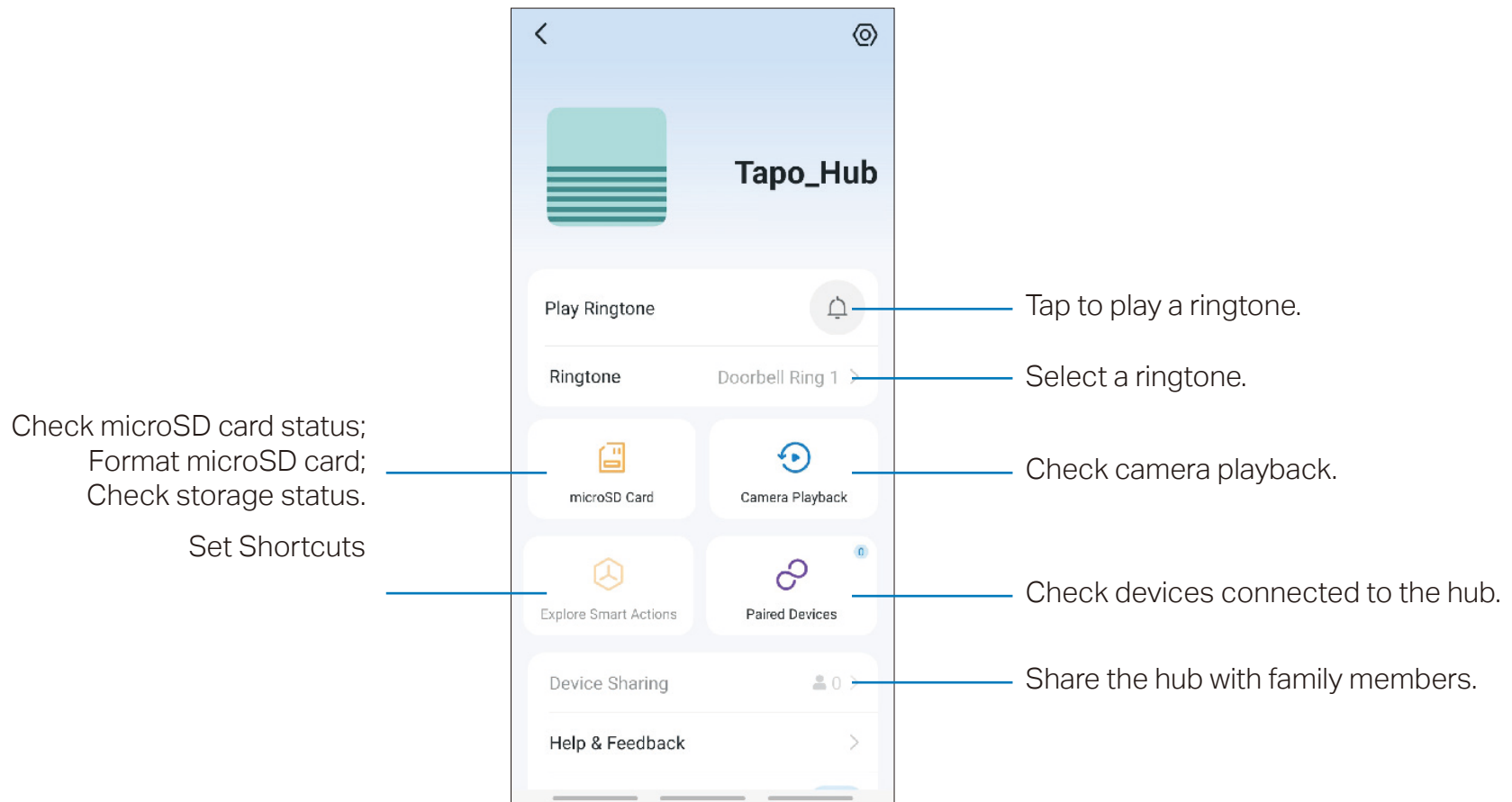

Manage Your Hub

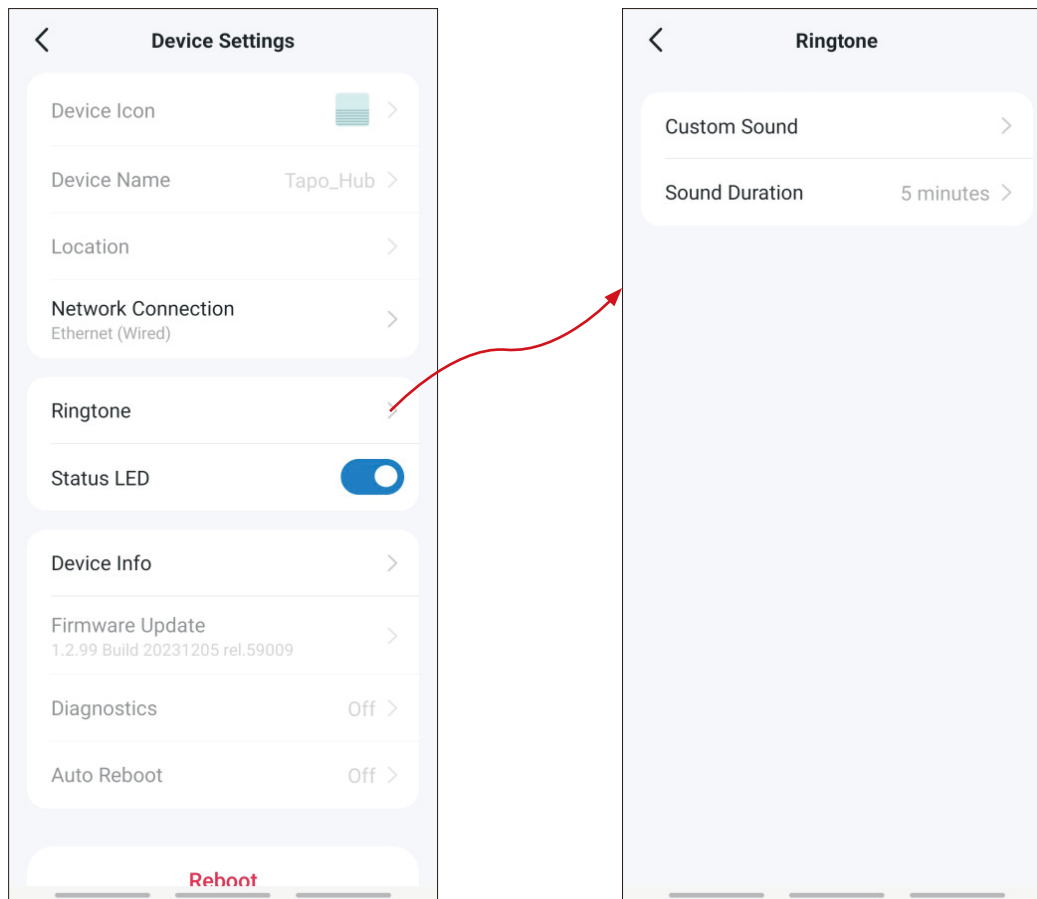
After you successfully set up the hub, you will see your device listed on the home page. You can view and manage your hub from anywhere at any time with the Tapo app.
